

Who is CASA of Terrebonne?

CASA of Terrebonne is a 501(c)(3) non-profit organization based in Terrebonne Parish. It was incorporated in 2000 by Danna Schwab and Carolyn McNabb.

The Court Appointed Special Advocate (CASA) program was created to assist children who are subject to court proceedings due to abuse, neglect and/or abandonment. CASAs are trained volunteers who are appointed by a Judge to provide one-on-one advocacy for a child who is under the jurisdiction of the courts.

Mission Statement

The mission of CASA of Terrebonne, Inc. is to be an independent and objective presence in the courts by speaking for the best interest of abused and neglected children of Terrebonne Parish.



We promote and support trained community volunteers to represent our children and help secure for each child a nurturing, safe, and permanent home.

What do volunteer advocates do?

1. Monthly Visits

Our volunteers meet at least monthly with their children to assess their best interest.

2. Court Hearings

Our volunteers and supervisors attend court regularly to ensure that both state and federal guidelines are being met regarding CASA children.



3. Advocacy

Our volunteers monitor services to ensure that all needs are being met regarding their child.



4. Documentation

Our volunteers are required to keep fact-based notes regarding all interactions with involved parties.



Our 2020 Goals

At this time CASA of Terrebonne is currently serving 85 children. However, there are 151 children who are on our waiting list who need a CASA volunteer. Our goal is to bridge this gap by recruiting, training and retaining more volunteers.



It goes without saying that our CASA children have seen many struggles and heartaches. For many of our children, education has never been a priority. This is why we recently began a new program called CASA Traveling Tutors. We want to link each child with a tutor if they are struggling academically.
